DENNY FLAHERTY

I'm told I opened my eyes for the first time on November 24, 1940, in Columbus, Ohio. As a first-born, I enjoyed the only-child attentions of my Irish-Catholic parents until my world was turned upside down by

the arrival of my brother and two sisters. We were now a family of six. My father, in pursuit of a better job, accepted a photo-engraver position with *Collier's* magazine in nearby Springfield. Seven years later, *Collier's* folded which resulted in another move. We ended up in Rhode Island, where I would finish high school. We had no money for college and my grades weren't exactly scholarship-worthy. Obviously, it was time to leave the nest. And what better way for a fledgling to take wing than with the United States Air Force.

In 1958, I started on a path that would include 30 years of active military duty with the Air Force, specializing in communications-electronics. Nearly one-half of my military career was spent abroad on tours in the Middle East, Central Europe, the coast of the Mediterranean, Southeast Asia and two tours in the Pacific.

But let me back-up for a moment. In 1959, I met the rest of my life in Ankara, Turkey. She was a 17 year-old senior in the American dependents' high school and I was an 18 year-old two-striper without a penny to his name. Long story short, we later married in Germany, raised two sons, and recently celebrated our 51st wedding anniversary. Our travels eventually brought us to Arizona and Williams Air Force Base, near Mesa, where I retired from active duty in 1988.

After leaving the Air Force, I attended graduate school and obtained a master's degree in public administration. With my new degree in hand, I was pleased that the State of Arizona offered me

the opportunity of a second career. Over the next 14 years, I became an in-house management consultant specializing in strategic and quality management. But eventually, the long daily commutes from our home in Chandler to the state capital would take their toll. And in 2004, I decided to retire for good.

My epiphany regarding Compassion & Choices occurred while watching "How to Die in Oregon." I was explaining to one of our sons how strongly I felt about a legal option for aid-in-dying. He looked me in the eye and said, "Dad, you're retired. You've got the time. Why don't you get off your butt and do something about it!" So here I am, reporting for duty!

SUPPORTERS SURVEY We Need Your Feedback Regarding Aid in Dying Legislation

Compassion & Choices Arizona would appreciate your feedback about support for Aid in Dying legislation in our state.

For several months we have been conducting internet and telephone surveys of members, donors, and other supporters who have expressed an interest in Aid in Dying. We realize we have not contacted everyone. If you have not yet responded to the survey, here is your opportunity.

We need your feedback because responses to this survey will help us develop a list of active supporters in each legislative district in Arizona. We will use these lists whenever Aid in Dying legislation is introduced in the Arizona legislature. When that happens, we will alert all active supporters via email and ask them to (1) contact their state legislators, (2) identify themselves as constituents, and (3) voice their support for the Aid in Dying legislation.

Our board member, Margot Champagne, is preparing a paper focused on the pros and cons of the Oregon model law. This study is not intended to result in the organization taking a position at this stage. The paper will be circulated to their state units for discussion. It may or may not lead to more formal action.

WHY DONATE TO COMPASSION & CHOICES?

What motivates our members to donate? We'd like to share this story sent to us recently by Arizona member Betty Sanneman.

Our family has just made a contribution to Compassion & Choices in honor of Netta Capetz, the mother of Nikki Capetz who recently became a member of Compassion & Choices.

We consider Nikki a member of our extended family and we witnessed the loving care Nikki gave her mother during the last few years of her life. Her mother lived in Minnesota and Nikki traveled there, got Netta set up with a good doctor and an adult care home with only five or six residents. Nikki was very particular in selecting the home, wanting to make sure it would give her compassionate care and be just the right place for her Mom. She then traveled back and forth to Minnesota every few months and stayed several weeks to monitor her situation and to participate in her care.

Being there so often gave Nikki a good understanding of her mother's condition, her medical needs and her degree of suffering.

Netta had a Living Will and she had chosen Nikki as her Power of Attorney but when Netta's condition deteriorated to the point that Nikki believed her mother would no longer desire further treatment, the doctor and the adult care home owner would not honor her mother's wishes. This caused more suffering for Netta and led to Nikki's determination to do everything she could to prevent needless suffering for others at the end of their lives

She found Compassion & Choices the perfect vehicle for her to work for her cause. You are doing great work and it is for this reason that we chose to make a contribution to your organization to honor the life of Netta Capetz and the devotion of her daughter, Nikki.
